For tax consultation - Tax return - forms brigade Hoorn location library Hoorn you need to bring:

Personal data:

your social security number (BSN) and that of your partner and children

your account number

your DigiD and that of your partner

Revenue:

your annual statements for 2020

And if you don't have one: your pay slips

partner maintenance received

Bank accounts:

the 2020 annual statement of your checking account

the 2020 annual statement of your savings account and that of your children

the annual overview 2020 of your investments

Live:

the WOZ value of your home with reference date 1 January 2019

This value is stated on the WOZ decision that you received from the municipality last year.

the annual statement of your mortgage

when buying or selling your property: the notary settlement

Deductions:

You need proof of payment. Think of:

Gifts

care costs that you have not been reimbursed

You may not deduct the Zvw own contribution, health insurance premium and the excess.

paid partner maintenance

if you were not entitled to study funding: study costs paid

Other:

data on loans and other liabilities

details of annuity premiums paid

an overview of paid disability insurance (AOV)

dividend data

Only if you have had it:

the provisional income tax assessment for 2020

the provisional tax assessment income-dependent contribution Zvw for 2020

Decisions of the Tax And Customs Administration or Court or UWV and SVB

Optional e.dentifier (ABNAMRO) or Rabo scanner
